Minimum English Proficiency Requirements for Graduation

- 1. National Taipei University of Technology (hereinafter referred to as "NTUT") prescribes these "NTUT Guidelines for Minimum English Proficiency Requirements for Graduation" (hereinafter referred to as these "Guidelines") pursuant to the NTUT Academic Rules in order to improve the English proficiency and career competitiveness.

 2. Each student admitted to the four-year college of the day division from the Academic Year 2012 or the five-year vocational college program, or the four-year college of the night division from the Academic Year 2018 must meet one of the following English proficiency test criteria to pass the minimum English proficiency requirements for graduation:
- (1) NTUT "English Proficiency Test for Minimum Graduation Requirement" Level A or Level B.
- (2) Scoring in accordance with CEFR level B1 on English proficiency tests provided by reputable international or local institutions listed in Schedule 1.
- (3) Other English language tests provided by reputable international or local institutions not listed in Schedule 1 must provide a complete research report certified by a language test expert showing its test results in reference to the CEFR level. The test score shall be compared to CEFR level B1 and approved by the Department of English.

- 4. Whoever meets any qualification of the NTUT "Guidelines for Waiver of English Courses"
- will be deemed to have passed the minimum English proficiency requirements for graduation.
- 5. Any student who fails to meet the English proficiency test criteria applicable to the admission year under these Guidelines will be deemed to have passed the minimum English proficiency requirements for graduation if she or he meets one of the following criteria:
- (1) Whoever has obtained the minimum score of one of the English proficiency tests

specified in Schedule 3 may apply with the Academic Affairs Office to enroll in the "Course in English language Proficiency Tests" under the NTUT "Professional Business English Bridge Program" courses in the junior year of a four-year college program, or in the second semester of the fourth year of a five-year vocational college program. The student will be deemed to have passed the minimum English proficiency requirements for graduation upon successfully completing the course(s).

(2) Whoever fails to become eligible for the "Course in English language Proficiency Tests" under the "Professional Business English Bridge Program" by the end of the graduating semester may enroll in two sessions of "Course in English language Proficiency Tests" of the "Professional Business English Bridge Program" starting from the fifth year. The student will be deemed to have passed the minimum English proficiency requirements for graduation when successfully completed the course.

Whoever requests to enroll in the "Course in English language Proficiency Tests" under the "Professional Business English Bridge Program" for passing the minimum English proficiency requirements for graduation under subclause 1 must have registered their English proficiency test grade, and may not recognize the same courses as "elective credits of cross-specialization". Evaluation and assessment for the "Course in English language Proficiency Tests" under the "Professional Business English Bridge Program" are set by the Department of English.

- 6. Each student shall sit any of the English language tests specified in Schedule 1 at least once. Whoever fails to obtain the passing score may use any of the passing criteria of the Japanese, Korean, French, German, Spanish, Thai, Vietnamese language tests to substitute for the minimum English proficiency requirements for graduation.
- Overseas students shall exclude their official languages. This paragraph does not apply to the graduate students of the Department of English.
- 7. The minimum English proficiency requirements for graduation application to the undergraduate students of the Department of English. Other departments may also prescribe a higher standard of the minimum English proficiency requirements for graduation. These criteria shall be passed by the Academic Affairs meeting, and reported to the Office of Academic Affairs for review.
- 8. Any student with a disability who has completed an assessment at the Student Counseling Center and Disability Support Service of the Office of Student Affairs may be exempt from the external English tests subject to the review and evaluation of the individual conditions by the relevant NTUT units, and enroll in one course of the "Professional Business English Bridge Program". The student will be deemed to have passed the minimum English proficiency requirements for graduation when successfully completed the course. The student may be exempt from the minimum English proficiency requirements for graduation.

- 9. Each student who has met the minimum proficiency requirements under these Guidelines shall submit the application, original transcript and one copy to the academic affairs office of their division for review and record. Any student who requests for recognition of any language proficiency other than English shall submit the English proficiency test result obtained during study at NTUT.
- 10. Each student from a low-income or medium-low income household, and every disabled student may submit relevant proof and the original receipts of the registration fees of any foreign language tests set forth in these Guidelines for reimbursement for two times. The maximum allowance for each time is NT\$4,000.
- 11. Whoever has completed all required courses and credits of their department but has deferred the graduation due to the failure of passing the minimum English proficiency requirements for graduation may drop, if the requirement is met before the deadline of dropping courses, or withdraw from the registered after the deadline when she or he meets the minimum English proficiency requirement during a semester, and start the graduation exit processes. If the student is in the suspension of study, she or he must resume to school, pay the student insurance premium and internet usage fees, and complete the registration processes before applying for the graduation exit process.
- 12. The eligibility, registration process, and other procedures of the NTUT "On-campus English Language Test for Minimum English Proficiency Requirements for Graduation" shall be developed by the Media Teaching Center.

14. Transfer students and students who have changed their majors are subject to the English language test criteria applicable to the students of the new class in their admitted year.

The minimum English proficiency requirements for graduation for graduate students of day division are subject to the "Guidelines for Minimum English Proficiency Requirements for Graduation for Graduate Students of Day Division"

15. These Guidelines and any amendment thereof shall become effective upon the resolution of the Academic Affairs Meeting and the approval of the President.
